 MR. TROMBADORE: I'd like to inquire of staff as to whether we have heard from Mr. Irek?

MS. HILL: No, we have not. We made notice by publication to Mr. Irek in the New Jersey Law Journal and in the Neptune, whatever - - Asbury Park Press. And we had not heard from him.

We them were advised that he might be in North Carolina and we forwarded the package to the address that we were given in Raleigh, North Carolina. And then that mail came back as forwarding time expired. And we mail - - remailed to another address in Raleigh, North Carolina. That has not been returned.

MR. TROMBADORE: All right, Mr. Gaughran, we - - MS. HILL: But we have not heard anything.

MR. TROMBADORE: Thank you, Ms. Hill. Mr. Gaughran, we;ve had the benefit of - - of the - - the material submitted; and for record from below; what do you want to tell this Board that is not already in those papers?

MR. GAUGHRAN: I really don't think there's anything else that I can tell the Board, other than that early on in the investigation I personally spent countless hours in an attempt to try to locate Mr. Irek. But in terms of the hearing and - - I've nothing further to add other than the - - the two violations from the hearing panel 1.15b as far as the safekeeping, and 8.43 - - 8.43c, I feel

that there are violations.

MR. GAUGHRAN: I don't know. All I can say is that in my investigation he disappeared from Monmouth County, and the circumstances surrounding his disappearance I really can't say other than that from the - - the real estate development and the work that he was doing.

They were in economic shambles at the time that he disappeared.

TROMBADORE: Mr. Gaughran, thank you very MR. much. I appreciate your efforts on behalf of the system. Thank you.

MR. GAUGHRAN: Thank you.
