Dear Mr. Irek:

I serve as Senior Counsel for the New Jersey Lawyers' Fund for Client Protection ("Fund"). The Fund obtained a Default Judgment against you in the amount of \$5,000.00 on March 22, 1995. A copy of the judgment was sent to your attention. You failed to respond. The Fund entered this matter into the Comprehensive Enforcement Program ("CEP"). A notice was sent to your last known address advising that you must contact the Fund or your matter would be scheduled for CEP. You failed to contact the Fund, and the matter was scheduled for CEP on November 5, 2004. You failed to appear, nor did you contact me to discuss this matter. Please be advised that I am enclosing an Order signed by the Honorable Patrick F. McManimon on November 5, 2004. Judge McManimon has issued a bench warrant for your arrest, and you will only be released from incarceration once you pay the sum of \$5,000.00.

In addition, the Court has granted relief to the Fund in that driving privileges can be suspended if the Fund submits the appropriate documents to the Division of Motor Vehicles. I am enclosing a Notice of the Intent to Suspend your Driver's License. It is essential that you contact me within five (5) days of the date of this letter to resolve this issue. If I do not hear from you, then I will take the necessary steps to have your driver's license suspended.

RE: NOTICE OF INTENT TO SUSPEND DRIVER'S LICENSE/REVOKE NONRESIDENT DRIVING PRIVILEGE OR POSTPONE OBTAINING A DRIVER'S LICENSE

Your driver's license *or* nonresident driving privilege will be suspended; *or* if you currently do not have a driver's license, obtaining a driver's license will be postponed in accordance with N.J.S.A. 2C:46-2 as a consequence of nonpayment of court ordered monetary obligations. A bench warrant for your arrest



To avoid these consequences, you must pay \$ 5,000.00 by December 30, 2004 at the New Jersey Lawyers' Fund for Client Protection listed above.

If your driver's license becomes suspended as a result of this action, when this obligation is paid in full, the New Jersey Lawyers' Fund for Client Protection will notify Motor Vehicle Services that you are eligible for restoration of your driver's license **in regard to this matter**. You will receive a copy of the **Eligibility for Restoration of Driving Privilege Form**. You are responsible for paying a \$100.00 restoration fee directly to the Motor Vehicle Division at the time you apply for restoration of the license.

For further information relating to having your driver's license restored, after the New Jersey Lawyers' Fund for Client Protection has determined your eligibility for restoration, please contact the State of New Jersey, Motor Vehicle Division, Driver Control Services, P.O. Box 134, Trenton, NJ 08666-0134; telephone number (609) 292-7500.

If your driver's license is suspended, and if you are convicted of operating a motor vehicle while suspended, you will be substantially fined and may also face a period of imprisonment.


